#### Norma Kagle - Lot 73 Pinehurst

**Question** – We used to have a "Special Events" position on the board that had fundraisers to purchase items for LOP. I know that we have the individual groups such as Men's Club, Women's Club, & Circle of Friends" that have fundraisers but sometimes they're not for specific LOP needs such as campground electrical, cameras, etc. We generated money to use for Special Events. What happened to that effort? **Answer – Per Rick McCombe –** That now falls under future planning and hopefully one of the write-in candidates will assume that position.

David Harris - Lot 40-42 Pinehurst Estates

**Question** – How many maintenance people do we have? We used to have one BOD person and one part time person that managed everything.

Answer - Per Dave Lynch - Three.

Answer - Per Rick McCombe - That's one full time and two part time.

Steve Andrews - Lot 280 Woodland Heights

**Question** – Can we start planting trees at the campground before all the trees are gone and we have nothing but sun? The campers won't come if it's all sun.

Answer - Per Dave Lynch - Yes, that is a great idea!

### Connie Crawford - Lot 200-202 Woodland Heights

**Question** – Regarding the Shawdowbrook blight, if no luck with the judge this time, is there a different path we can take, like contacting the County, because they have a missing culvert?

Answer – Per Cindy LaFave – Marc David already contacted the County for a culvert and the County said "NO". Also, we started an Anti-Blight committee here at LOP and our first task is to define "What is the definition of Blight" and what kind of punishment (fines and/or liens on their property) do we implement for people breaking the rules. Then once determined, we will take our "Blight" definition and punishments to our attorney to ensure that we have legal standing. Our final step will be to update the LOP Rules and Regulations document so that everything is clearly spelled out and inform the LOP association members of this change.

Question – Is Marc Davis still identified as a sex offender?

Answer - Per Cindy LaFave - Yes

Question – Why don't we have the state police at the court to pick Marc Davis up?

**Answer – Per Cindy LaFave –** Because it is not a priority for them. By all means call the state police and see if they will come to the court on June 21, 2023. Keep in mind that there is no guarantee that Marc Davis will show up to court on that day.

Comment – Per Cindy LaFave – People have been spotted going to the campground and using the showers and the dump. We're going to also ask the lawyer what we can legally do to people who violate using the LOP common grounds when they are not in good standing.

**Comment – Per Norma Kagle –** Apparently there are a lot of activities going on at night at the campground and because of that the neighbor across put up cameras to monitor the situation. It might be good to contact them and review their cameras

Dawn Basler - Lot 207-208 Birchwood

Comment - Thank you to the maintenance people. LOP is growing like crazy.

Al Kohlhoff - Lot 44 Birchwood

Question – Who is in charge of the dam that controls the lake level? The water level is way low.

Answer – Per Rick McCombe – The Clare County drain commissioner.

Answer - Per Dave Lynch - The State of Michigan determines the water level.

Question – Is there a plan to treat the lake for weeds and algae? Did they already treat it this year?

**Answer – Per Rick McCombe –** PLM came out last week and surveyed our lake and will be treating the lake for algae & weeds next week. This will be the first treatment this year.

Marcy Wyrick - Lot 34-35 Woodland Heights

Question - Don't we have cameras at the campground?

Answer - Per Rick McCombe - No, not that we are aware of.

**Answer – Per Cindy LaFave –** We talked about putting WIFI and cameras at the campground but thought it would be a huge expense but now that two new fire rings were stolen and late-night activities are happening, maybe we should reconsider.

**Comment – Per Teri Morrow-Sutton –** We should also consider putting cameras on the exterior of swimming pool room and also in the pool area.

Comment - Per Connie Crawford - We have cameras on Pontoon Island but they don't work.

**Comment – Per Rick McCombe –** We probably should move this up to a higher priority on the list of things that need to be one.

**Comment – Per Dave Borle –** It's not just the blight people using the showers. Other people that just have campers come here to.
