#### **OFFICER'S REPORTS**

#### PRESIDENT'S REPORT - Rick McCombe

Rick deferred the Shadowbrook Drive blight update to Cindy Lafave.

Today March 11 is the deadline. Conrad Blain, 15 minutes before the deadline, gave the deed to Marc Davis which was filed with the Register of Deeds, dated back in February 2022. Monday our Attorney will file contempt of court, for permission to go in to clean up the property. We will have to hire a company with hazmat suits because of human waste on the property. It will cost about \$5000.00 to have them come in and clean it. We talked about LOP people helping but because of this issue we can't. The cost will be filed with the Judge within or by 30 days. Taxes have not been paid this year, the county will not do anything until the taxes have been delinquent for 3 years. We township will be hitting the property owner with \$300.00 tickets if not cleaned up. Neighbors are disgusted with them. Told to call the Health Department daily or weekly. No plumbing, class A sex defender, he (Marc Davis) is not registered at the address, can go on line to Michigan State Sex Offender to see. Lot #111. Freeman Township, legal address, T18N, R6W, section 24, lot 111, Birchwoods Heights, Freeman Township, Clare County MI. They didn't have a search warrant for Marc's arrest. Rod and Larry delivered their MA dues for this year. Are the Blains liable for the past dues? No Marc Davis is. When the Company comes in to clear the property, everything goes. Williams family couldn't sell their mom's house because of the blight on Shadowbrook. We can only take away their privileges. We will be assigned a code enforcement officer to enter the property during cleanup. We are trying to get copies of covenants from other HOA's in the area to see how they define blight so that we add a blight definition to our covenants. Our attorney says we don't have anything in our covenants to fine anyone. We will be working on our covenants to change this. Camping on member lots? Township doesn't allow it but they don't enforce it. (Members were allowed to comment and ask questions during this blight update session.)

# **VICE PRESIDENT'S REPORT – Rod Saunders**

Last month I brought up putting locks and chains at the boat launches. It would cost about \$1000.00 to do this for all 3 boat launches. A charge of \$25.00 is being proposed for all members who launch a boat on our lake. This will be a yearly charge and a key will be issued. Members with docks on pontoon Island will not be required to pay the \$25 launch fee. Key's can not be copied. Locks and keys will be changed every year. This money is going to support the lake. Hopefully no one passes around their key. Pontoon Island dock fees go to support OUR lake. We have a \$10,000.00 fund to support our lake. Campground will be paying \$25.00 also. There will be a key in the office. What about DNR? Key in the office that DNR can use. It takes 40 people to recoup the \$1000.00 cost of installing locks and chains. We are trying to make it fair so that all users of our lake share in the support of the lake. Our association is running low on funds. Everything is going up in price and so we have to raise charges also. What about floating docks? It cost about a \$1000.00 per floating dock. (Members were allowed to comment and ask questions about this proposal.)
